Hello

I really enjoyed reading your draft response and learning how you managed challenging behaviour within your business class, thank you for posting. I love the CREEL technique, definitely a good one to implement as you can increase the intensity if the students aren't responding. I certainly use a number of the steps in my own teaching, in particular the standing close to the student and using a look to get their attention. You have succeeded in highlighting the focus areas and explicitly linking them throughout. The literature you used supports what you did in the classroom.

I have a few suggestions, if you wish to take them on board :-)

- I noticed a bit of repetition in the second paragraph, 'I utilised' was used twice within two sentences and you used 'the seating plan' to start two sentences in a row. This can easily be changed by rewording text a little. The synonym tool in Word is my best friend when writing assignments!

- To strengthen why you used one strategy, you can say why you chose to use it over another one (as suggested by Lisa), for example, using the CREEL technique rather than planned ignoring or something like that.

- You have mentioned the artefact in brackets which is great, but you could strengthen this by mentioning what the artefact is within the sentence. For example, my mentor teacher commented that behaviour management was my strongest area of improvement, as evident in my Final Report (Artefact 4).
